SUMMARY

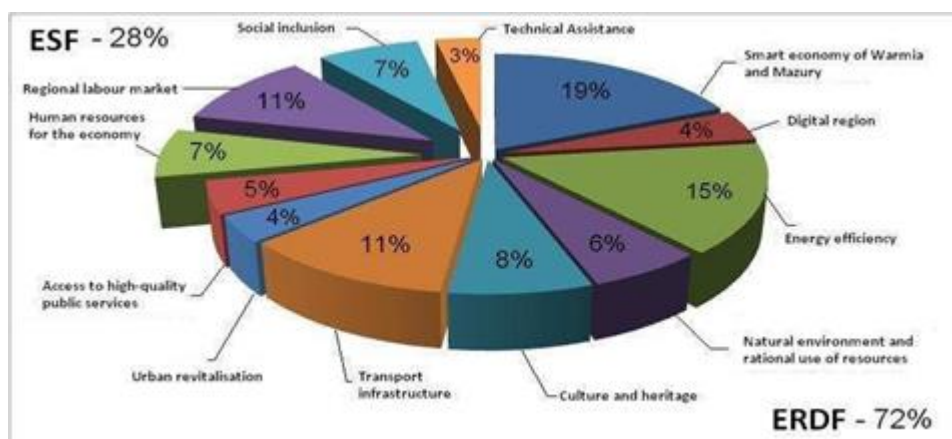
Regional Operational Programme for Warmińsko-Mazurskie Voivodship 2014 – 2020 (ROP WiM 2014 - 2020) is the successor of the *Regional Operational Programme Warmia and Mazury for the years 2007-2013* and partially constitutes a continuation of its support directions. It focuses on the economy of Warmia and Mazury, training of human resources, labour market integration, improving access to the public services, negating energy exclusion of the region, the natural environment, increasing the cohesion of transport system, urban revitalisation and its meagre communities and decreasing poverty in the region.

The expected results of the ROP W&M 2014 – 2020 will be achieved by means of thematic and territorial concentration of supported projects related to the following priority axes:

1. Smart economy of Warmia and Mazury.
2. Human resources for the economy.
3. Digital region.
4. Energy efficiency.
5. Natural environment and sustainable use of resources.
6. Culture and heritage.
7. Transport infrastructure.
8. Urban revitalisation.
9. Access to high-quality public services.
10. Regional labour market.
11. Social inclusion.
12. Technical Assistance.

The ROP WiM 2014 – 2020 is a two-fund operational programme, financed from the European Regional Development Fund (ERDF) and the European Social Fund (ESF). The total allocation of EU funds equals to 1 728 272 095 euro. 72% (i.e. 1 242 117 496 euro) is financed by the ERDF and 28% (i.e. 486 154 599 euro) is provided by the ESF.

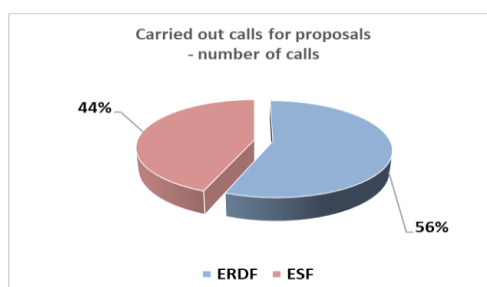
The Figure beside presents estimated allocation of resources for both funds and below the priority axes of the ROP W&M 2014 – 2020:



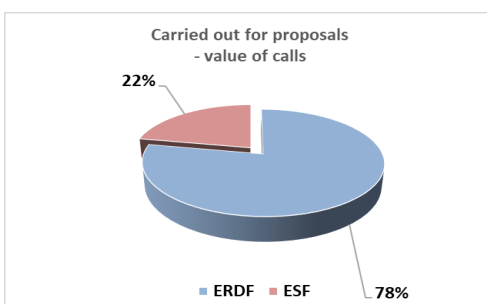
The ROP WiM 2014-2020 was adopted by the European Commission on 12 February 2015, subsequently on the 24th March, 2015 approved by the Management Board of Warmińsko-Mazurskie Voivodship. 2017 was the year of renegotiations with the European Commission of the provisions of operational programs for 2014-2020. The Warmińsko-Mazurskie Voivodship as the first region in Poland concluded negotiations and on December 31, 2017 forwarded to the European Commission the draft of the amended RPO WiM 2014-2020. Its approval took place on March 7, 2018.

In addition to the Managing Authority of the ROP WiM 2014-2020 (the Management Board of the Warmińsko-Mazurskie Voivodship), three Intermediate Bodies participated in the implementation of the Program: i.e. the Voivodship Labor Office in Olsztyn, Warmia and Mazury Regional Development Agency S.A. in Olsztyn and ITI Olsztyn. Until May 31, 2017 the functions of the Intermediate Body were fulfilled by the Voivodship Fund for Environmental Protection and Water Management in Olsztyn. From June, its tasks were taken over by the Managing Authority of the ROP WiM 2014-2020.

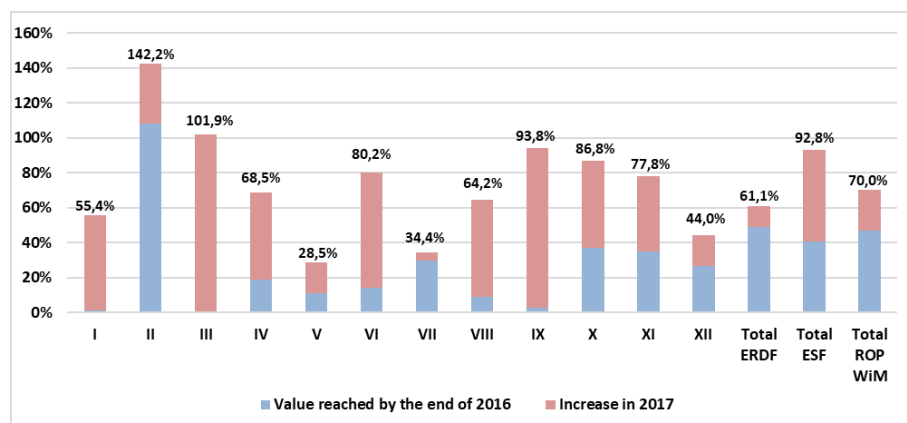
From the start-up of the Programme, altogether 286 calls for proposals were announced. The considerable value of announced calls for proposals was financed from the European Regional Development Fund (159 calls for proposals). As part of the European Social Fund 121 calls were announced.



Until the end of 2017, altogether calls were conducted for the total funding of 1.71 billions euro (1.34 billion euro under the ERDF and 372 million euro from the ESF). This represented approx. 99% of the entire budget of the ROP WiM 2014-2020



As a result of the calls, the formal evaluation has positively passed over 3 186 applications for co-financing. Their total value amounted to nearly 1.7 billion euro, of which approx. 1.3 billion euro are funds of the European Union. This represented approx. 70% of the allocation of the ROP WiM 2014-2020. In 2017, the value of applications correct in formal terms increased by 404 million euro (over 23 p.p). The value of the correct applications in terms of formal assesment in relation to the allocation of individual priority axes is presented in the chart below.



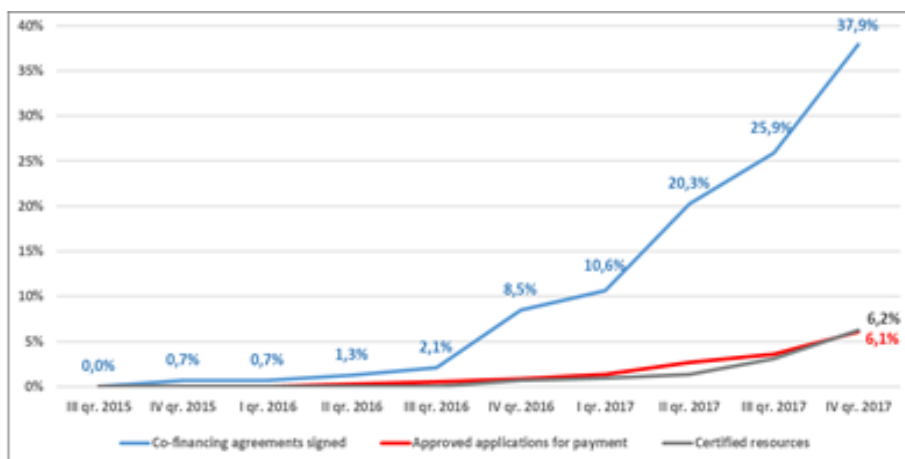

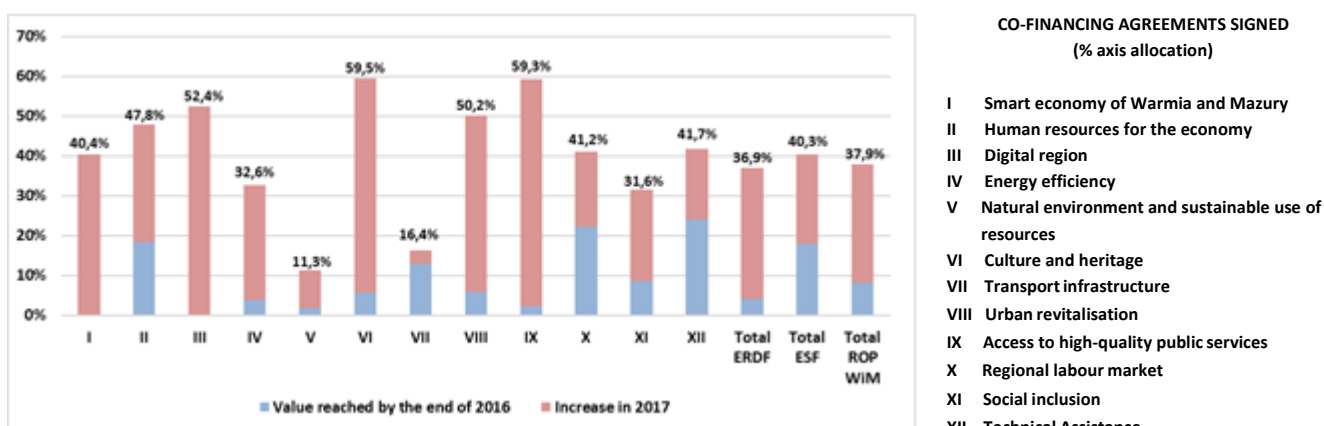
ROP WiM 2014-2020 is also implemented using returnable financial instruments. An amount allocated to them is over 60 million euro. Support for their use is granted to the SME's sector in the Warmińsko-Mazurskie Voivodeship. On May 29, 2017, an agreement was signed between the provincial government of the Warmińsko-Mazurskie Voivodeship and the National Holding Bank entrusting it the role of the Manager of the Fund of Funds. By the end of 2017, no agreements were signed with Financial Intermediaries, who will provide support to enterprises.

In 2017, the Managing Authority took steps to contract the funds of ROP WiM 2014-2020 as soon as possible. Their effectiveness is demonstrated by the implementation of the Program at the end of 2017. The value of signed co-financing agreements reached the level of 37.9% of Program allocation, whereof 29.9 p.p. was realized in 2017.

There has also been a steady, regular increase in the spending of funds (the value of approved applications for payment) and their certification.

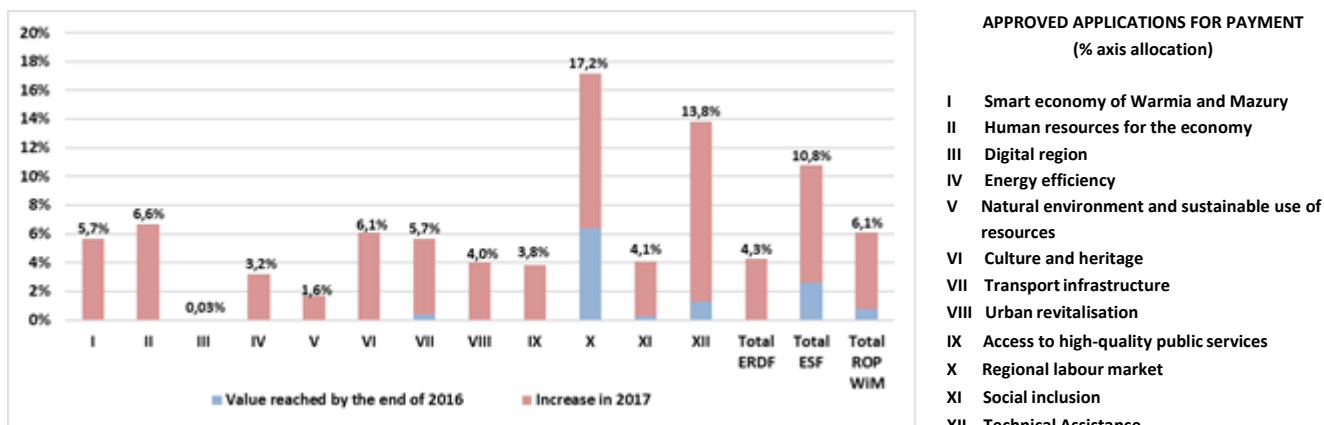


By the end of 2017, 1 396 contracts were signed and 27 decisions were issued (for projects in the Technical Assistance axis) with a total value nearly 890 million euro. Nearly 655 million euro is co-financing from the European Union (38% of the allocation of the ROP WiM 2014-2020), including 459 million euro from the ERDF (about 36.9% of ERDF allocation) and ESF - over 196 million euro (about 40.3% ESF allocation). The year 2017 brought an increase of 1 051 contracts/decisions for co-financing projects with EU funds in the amount of over 517 million euro. The value of co-financing agreements signed in relation to the allocation of individual priority axes is presented in the chart below.

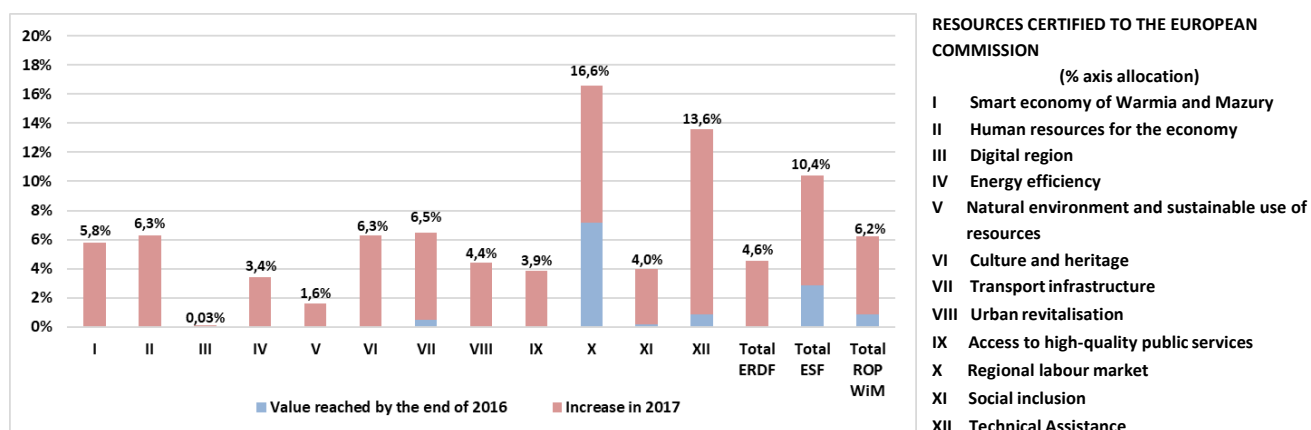


The total value of European Union co-financing issued by the beneficiaries, based on approved applications for payment, amounted to nearly 106 million euro (about 6.1% of the allocation of the ROP WiM 2014-2020), therein ERDF for over 53 million euro (about 4,3% of ERDF allocation) and

ESF amounting to over 52 million euro (about 10.8% of ESF allocation). The year 2017 brought an increase in the funds spent by the beneficiaries in the amount of over 92 million euro. The values of approved applications for payment in relation to the allocation of individual priority axes are presented in the chart below.

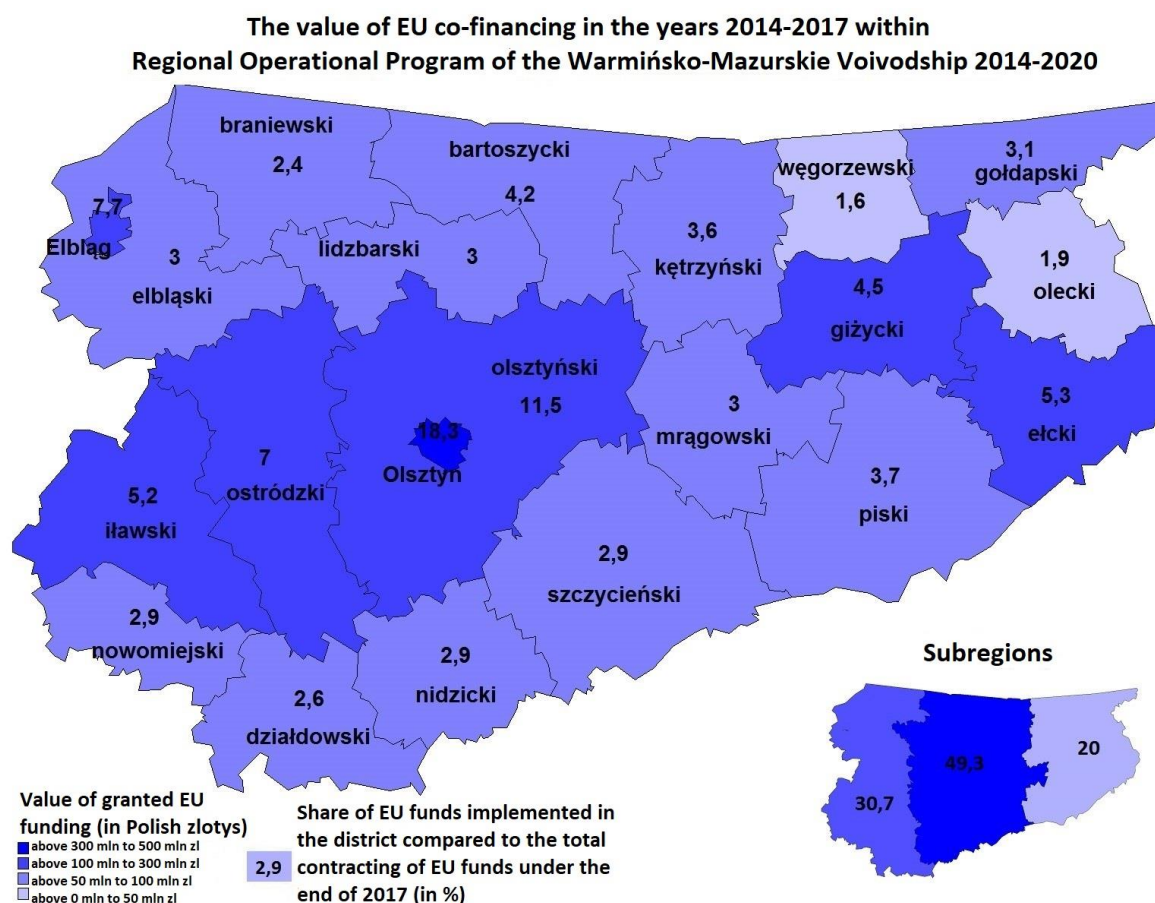


The amount of over 126 million euro of eligible expenditure, incurred by the beneficiaries has been submitted for certification to the European Commission. 107 million euro of expenditures are European Union funds (about 6.2% of the allocation of the ROP WiM 2014-2020), therein ERDF for the amount of approx. 57 million euro (approximately 4.6% of ERDF allocation) and ESF for almost 51 million euro (approximately 10.4% of the ESF allocation). The year 2017 brought an increase in EU funds certified to the European Commission in amount of nearly 95 million euro. The values of certified EU funds in relation to the allocation of individual priority axes are presented in the chart below.



For each operational program, the European Commission sets the levels of EU funds that should be certified by the end of a given year (the so-called "n + 3 rule"). In the case of ROP WiM 2014-2020, the first year in which the above-mentioned principle is used is 2018. The level of certification achieved at the end of 2017, i.e. over 107 million euro of EU contribution, represented approx. 45% of the liability resulting from the "n + 3 rule" at the end of 2018. The implementation of a significant part of the contracted investments will end in 2018, which will interleave into achieved results in the scope of spending and certification of funds. With this in mind, no threats are identified in achieving the goal resulting from the "n + 3 rule".

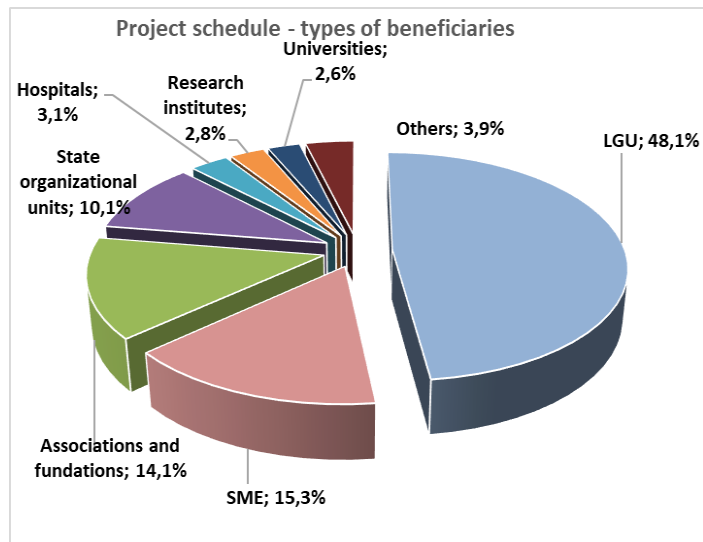
The spatial distribution of the support provided (excluding the projects of the Technical Assistance axis and implemented with the use of financial instruments) shows that the highest value of EU funds went to the Olsztyn subregion (about 49% of the total contracting of EU funds). In the Elbląg subregion, the value of EU funds in the implemented projects was about 31% of the total contracting of EU funds, and in the Ełk subregion - about 20%. As the map below shows, the support went to each powiat. The most funds received was by the poviats from the central part of the voivodship, in particular the city of Olsztyn (over 18.3% of total contracting of EU funds). and the olsztyński powiat (about 11.5% of total contracting of EU funds).



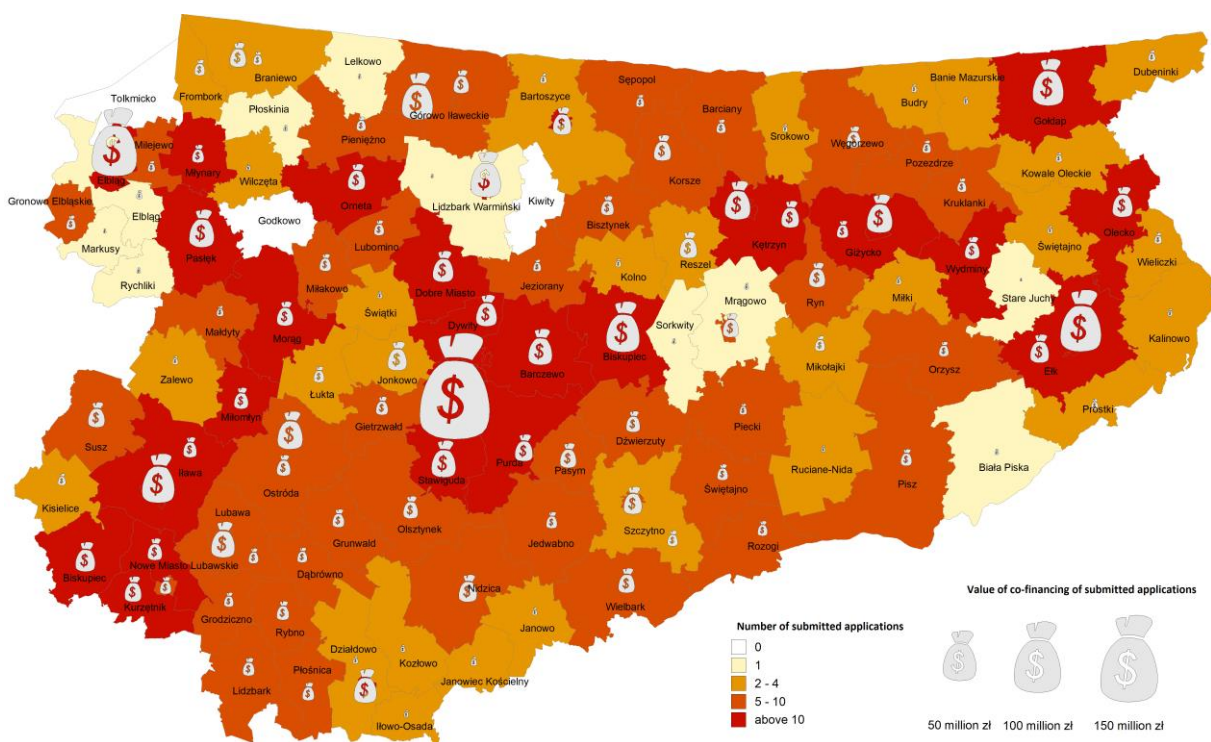
The value of EU co-financing for projects implemented in rural areas was approximately 113 million euro. This constituted over 17% of the value of all projects and about 6.5% of Program allocation.

A part of activities/sub-measures of the ROP WiM 2014-2020 was designated for the implementation of projects implemented in the formula of Integrated Territorial Investments (ITI Olsztyn and ITI" Elbląg and Ełk). The total amount of EU funds allocated for implementation with the use of this tool is over 113 million euro, of which approx. 58 million euro as part of ITI and approx. 55 million euro as part of ITI". By the end of 2017, the value of EU co-financing of signed contracts amounted to approx. 68 million euro, of which approx. 40 millions euro as part of ITI and approx. 28 million euro as part of ITI". This represents almost 60% of the total allocation earmarked for the implementation of these instruments (almost 68% of ITI allocation and over 51% of ITI" allocation). This shows that the implementation of Integrated Territorial Investments under the ROP WiM 2014-2020 is at a much higher level than the implementation stage of the entire Program.

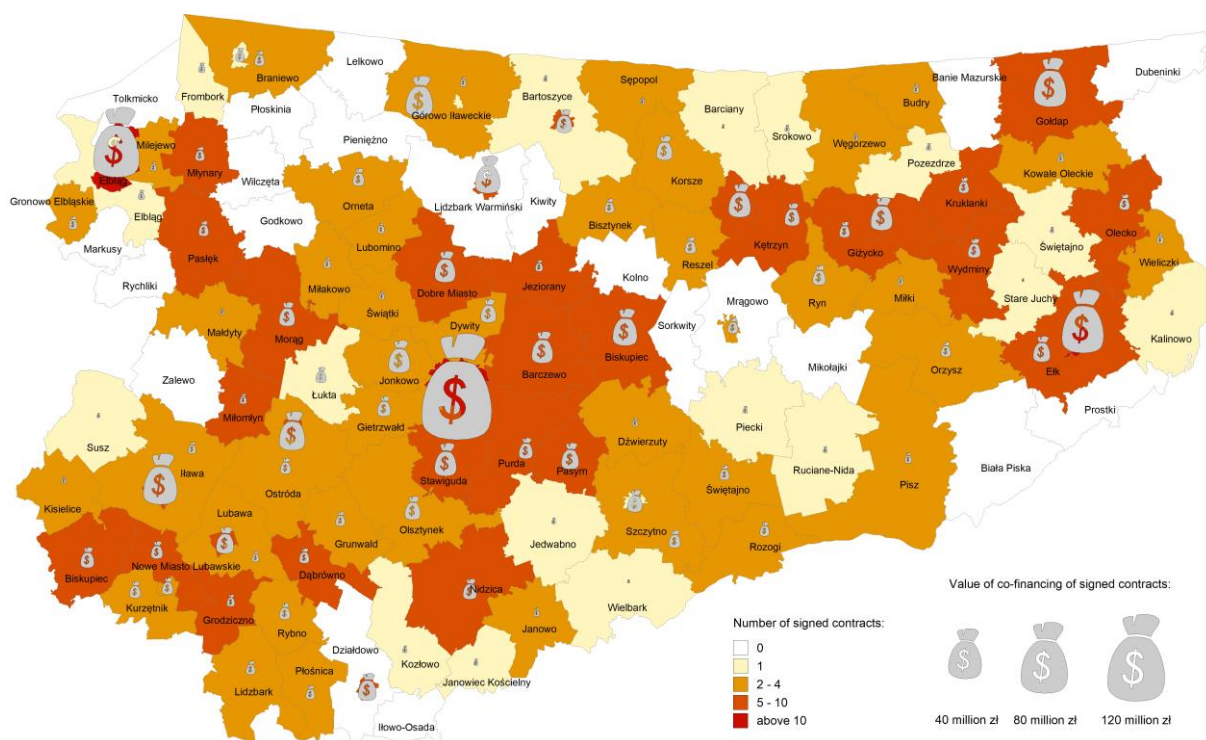
The main beneficiaries of the support of the Regional Operational Program for the Warmińsko-Mazurskie Voivodship for the years 2014-2020 were territorial self-government units and their organizational units - 48.1% of the value of EU co-financing of the contracts signed. Otherwise, EU support went to enterprises - 15.3%, foundations and associations - 14.1%, state organizational units - 10%. The share of other types of beneficiaries did not exceed 4 p.p.



As the map below shows, of all local government units only three did not apply for funds under the ROP WiM 2014-2020 (they did not submit any application for co-financing). These are the Godkowo commune, the Kiwity commune and the Tolkmicko commune.



Local government units that did not implement any project under the ROP WiM 2014-2020 (they have not signed any financing agreements) are much more frequent, i.e. 21 communes. The map below presents the distribution of projects implemented by individual municipalities from the Warmińsko-Mazurskie Voivodeship.

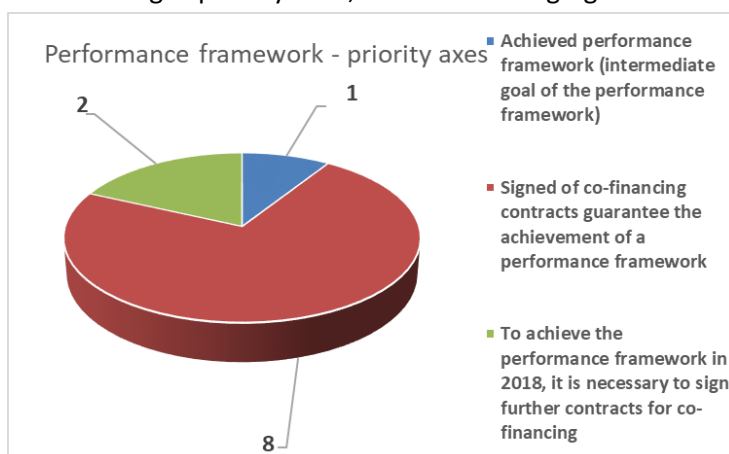


In terms of sectors of the economy, the highest amount of funds was directed to public administration - 24.2% of the value of EU co-financing contracts signed, education - 11.1%, financial and insurance activities - 9.3% and healthcare - 6.1%. The share of other sectors of the economy in the total value of EU co-financing of signed contracts did not exceed 4 p.p.

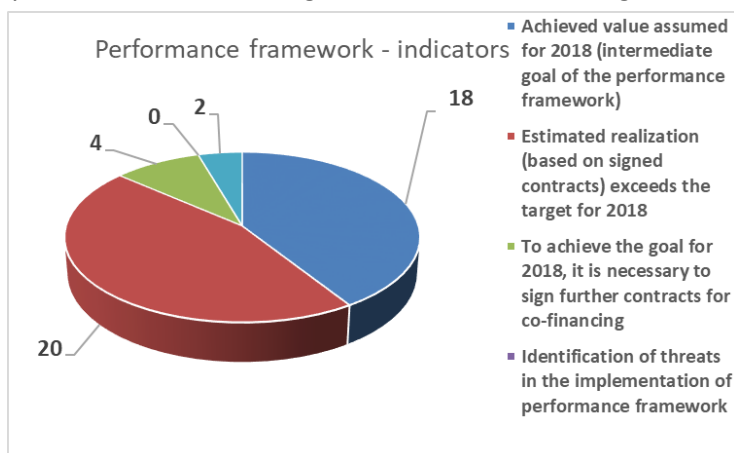
A positive aspect of the implementation of the Regional Operational Program for the Warmińsko-Mazurskie Voivodship 2014-2020 is the proper progress in the implementation of the performance framework, i.e. the set of indicators assigned to individual priority axes together with the assumed intermediate objective (for 2018) and the final goal (for 2023). In regards to activities aimed at achieving in 2018 the intermediate goals of the performance framework, the Managing Authority has been taking over from the beginning of the implementation of the Program (i.e. from 2015).

In the ROP WiM 2014-2020, 11 priority axes were covered by the performance framework. As of the end of 2017, the priority axis Regional labor market has already reached the intermediate goals of the performance framework. For the next eight priority axes, the co-financing agreements signed guarantee the implementation of intermediate objectives. Only in the case of two priority axes, to achieve the assumed values of indicators in 2018, it is necessary to sign further contracts for co-financing.

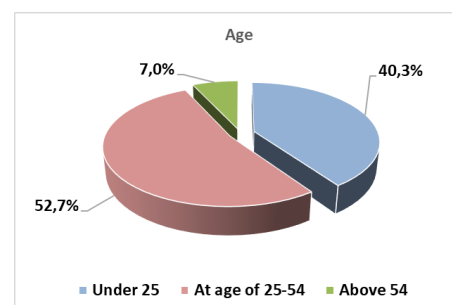
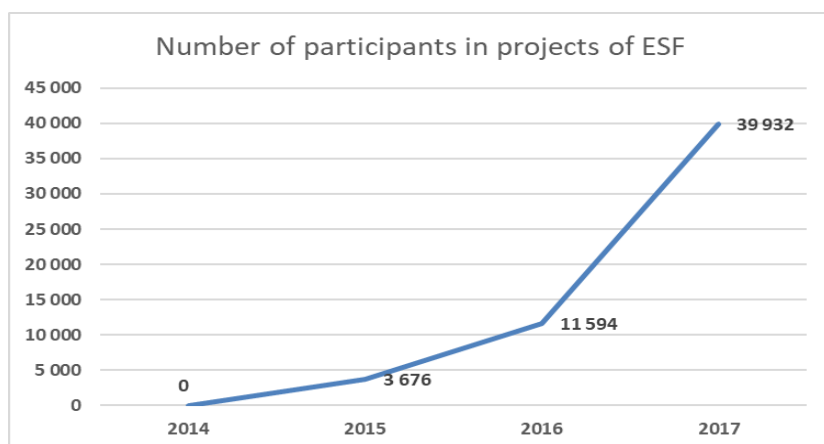
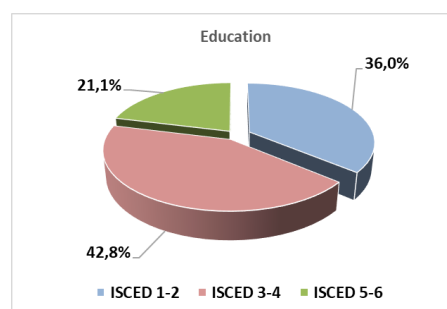
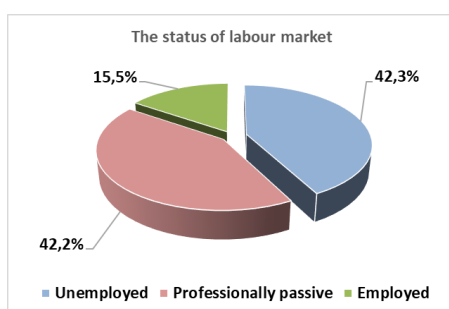
As part of the implementation of the ROP WiM 2014-2020 there are 44 indicators. By the end of 2017, about 41% of indicators (18 out of 44) achieved an intermediate target determined for 2018. Current analysis show that the co-financing agreements signed until the end of

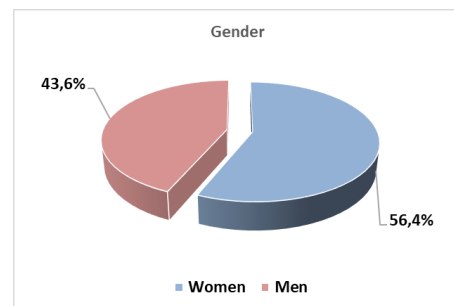
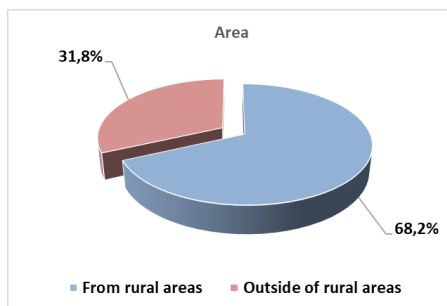
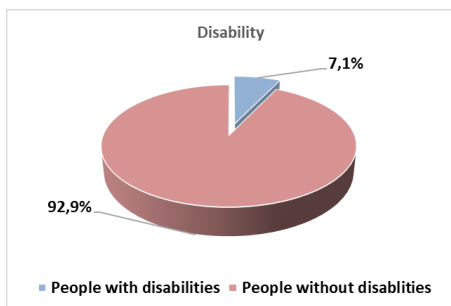


2017 guarantee the implementation of intermediate targets of another 45% of implementation indicators (20 out of 44). Only for 4 indicators, mainly under the axis Natural environment and rational use of resources, it is necessary to conclude further agreements on co-financing for full implementation of intermediate objectives. Delays in the implementation of the axis Natural environment and rational use of resources is due primarily to delays at the national level in the updating of strategic documents conditioning the implementation of calls for proposals (i.e. the National Waste Management Plan and the National Program for Municipal Wastewater Treatment). This occurred only in mid-2017, as a consequence, the call for proposals could be announced in the second half of 2017 and in 2018.



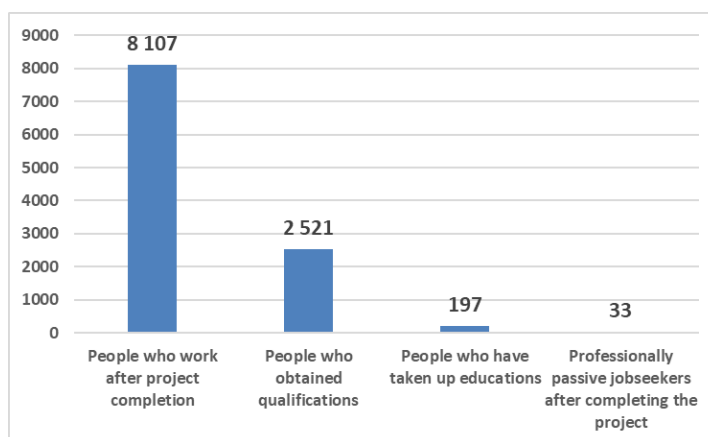
The total number of participants co-financed under the European Social Fund in ROP WiM 2014-2020 by the end of 2017 has already reached the level of nearly 40,000 people. The year 2017 brought by far the largest increase in this area. The graphs below present both the growth of project participants in individual years of implementation as well as their characteristics in terms of age, gender, status on the labor market, education, housing area and disability.





Despite the fact, that by the end of 2017, the implementation of many projects has not been completed yet, the first effects and results of the support provided under the ROP WiM 2014-2020 are already emerging.

Of all participants supported under the European Social Fund, over 8.000 people work after leaving the project. A significant number, over 2.500 persons, obtained qualifications as a result of the support received from the ROP WiM 2014-2020. The chart presents the results of projects implemented under the ESF achieved at the end of 2017.



How EU support under the ROP WiM 2014-2020 can change and change the situation of the inhabitants of the Warmińko-Mazurskie Voivodeship, their quality of life, work, education, is demonstrated by the statements of beneficiaries and participants under the following Webinars. They were implemented as part of the information and promotion activities conducted by the Managing Authority.

Project title: Today dismissed from work, tomorrow employed	
Beneficiary: Warmia and Mazury Vocational Development Center in Olsztyn	
EU funding: 3 135 979.20 zlotys	
	
<p>The project promotes self-employment, entrepreneurship and the creation of companies, including innovative micro-, small and medium-sized enterprises. It is a response to the existing local demand for access to new jobs. Self-employment is the best instrument to reduce unemployment in the region. Participation in the project gives the opportunity to improve professional qualifications enabling return to the labor market, active participation in the labor market and raising self-esteem and belief in own competences through participation in trainings and workshops. The subsidy path includes workshops on setting up and running a business, preparing a business plan, non-returnable financial support in the amount of approx. 23,000 zlotys and consulting while conducting business.</p>	<p>The project is addressed to 272 people dismissed from work or persons at risk of dismissal for reasons attributable to the workplace. The aim of the project is to counteract the negative effects of restructuring processes in the subregion. The project assumes maintaining the professional activity of the participants by providing outplacement support of trainings, consultations and grants.</p>

Project title: From passivity to activity - socio-professional activation of people at risk of social exclusion
Beneficiary: Elbląg Consultative Council for the Disabled (ERKON)
EU funding: 1 056 228.00 zlotys



The project is a response to the identified needs of the residents of the Elbląg powiat, struggling with social and professional problems. It is oriented, among others, to facilitate access to the labor market for women and people with disabilities.

Its aim is to raise the level of social and professional activity of 60 people at risk of social exclusion, including 36 people with

disabilities. Three tasks were planned - multi-profile diagnosis, social and professional reintegration - aimed at identifying individual problems and adjusting social and professional support to the participant. Project participants will be covered by, among others, support of a psychologist, vocational counselor, job coach, legal counseling, training, internships. A measurable indicator of the result will be employment for 15 people.

All activities undertaken during the project implementation are based on the use of the supported employment model based on the developed model "age of hot potato". Innovation of the implemented employment model consists primarily in preparing an individual path for each job-seeking person who will be closely adapted to his/her professional and life situation.

Project title: Consultation Point on Domestic Violence in Wydminy

Beneficiary: Wydminy commune

EU funding: 858 327.50 zlotys



The project aims to increase the effectiveness of counteracting domestic violence and to initiate and support activities aimed at raising public awareness in terms of the causes and effects of violence in the family. In this way, the first step was taken to raise public awareness of combating the phenomenon of domestic violence. Activities have been given in the field of counteracting domestic violence, the legal framework, thus increasing the rank of tasks by the local government.

The aim of the project is to provide support for 120 people in the municipality of Wydminy (60 perpetrators and 60 victims) using and experiencing domestic violence through the services of the Consultation Point on Domestic Violence in Wydminy by the end of January 2019. The project

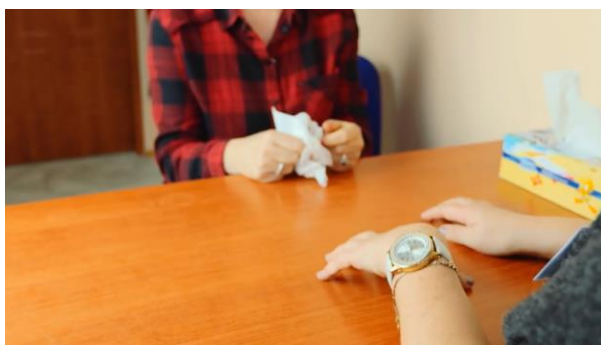
responds to the diagnosed needs of residents, because previously, such a comprehensive service was not available.

Project title: Kindergarten in SEC in Szymanów is a chance for development and functioning in the "big city"

Beneficiary: Ostródzki powiat

EU funding: 188 087.23 zlotys



Thanks to the implementation of the project the opportunities for development of children from special kindergarten in Szymanów by providing them access to free activities (concentration training, social skills, therapies developing key communication competences or communication skills in a foreign language, psychoeducational activities for children with behavioral disorders and

development) with the pedagogical support of parents and improvement of teachers' professional competences. Improvement of the quality and effectiveness of the special education system will allow to maintain and increase the reputation of the facility and will affect the possibility of exporting educational services out of the powiat.

The project is part of the extensive activities of the Ostródzki powiat undertaken to increase the quality of educational services provided in the field of special education. Activities planned in the project will improve the quality of educational services provided by:

- raising the qualifications and competences of teachers, i.e. participation in improvement courses, training in the analysis of children's behavior, pedagogical activities of a therapeutic nature,



- raising parents' skills in working with a disabled child through participation in workshops,
- developing key children's competences and providing access to additional classes developing communication skills and communication skills in a foreign language. Their aim is to create opportunities for parents to learn methods, forms or techniques of working with children with sensory disorders.

The European Regional Development Fund also identifies a number of investments implemented in 2017 under the ROP WiM 2014-2020, which are examples of "good practices" of projects co-financed from EU funds. Below are few of them.

Project title: Construction and assembly of a 233kWp photovoltaic installation on the premises of ELTEL Networks Energetics J.S. Co.

Beneficiary: ELTEL Networks Energetics Joint-Stock Company

EU funding: 816 320.45 zlotys



The main objective of the project is to reduce the company's energy consumption from conventional sources, thereby reducing greenhouse gas emissions and increasing the use of energy from renewable sources and improving air quality. As a result of the project, not only will it improve the production capacity of the so-called "green energy", but there will

be an increase in the share of renewable energy in the total electricity production in Warmińsko-Mazurskie, and the reduction of greenhouse gas emissions to the atmosphere in the region is also assumed.

The project involves the construction and installation of a photovoltaic installation for the production of electricity from solar energy with a total capacity of 233kWp. The investment includes the construction and assembly of the photovoltaic system together with the infrastructure. As a result of the project implementation, the quality of life and health protection of residents will improve and the company's image will improve as a company promoting environmental protection and sustainable use of resources.

Project title: Construction of a natural medicine plant along with the extension of the spa promenade in the health resort of Gołdap

Beneficiary: Gołdap commune

EU funding: 17 946 913.35 zlotys

The aim of the project is to increase the tourist attractiveness of the Gołdap commune through the development of a spa and recreation base. The investment includes the construction of the Natural Therapy Facility along with the extension of the Spa Promenade. The building will have 3 rehabilitation zones:

- physiotherapy (peloidotherapy, cryotherapy, inhalatories, massages, doctor's office),
- thermotherapy (saunas, tepidarium),
- hydrotherapy (rehabilitation pools).

All zones will be equipped with the most modern rehabilitation equipment. Spa Promenade in Gołdap will be extended to Jeziorowa street. There will be a parking lot for 42 vehicles, a 430 m long road, a cycling path of 0.5 km and 2 km of pavements. The investment will be complemented by elements of small architecture such as benches, bicycle racks and rubbish bins. New plantings of greenery will be made. Additional energy-efficient lighting of the complex will be installed.

Project title: Center for Environmental Research and Innovative Food Technologies for Quality of Life

Beneficiary: Institute of Animal Reproduction and Food Research of the Polish Academy of Sciences

EU funding: 77 611 371.42 zlotys

The aim of the project is to create a supra-regional specialized scientific-research base and research and implementation by strengthening the potential of the Polish Academy of Sciences in Olsztyn. The project will include the "Center for Environmental Research and Innovative Food Technologies for Quality of Life", building a competitive advantage of the region and the country through specialization in the agri-food industry and effective use of pro-innovation infrastructure enabling implementation of activities coinciding with smart specializations of the region: "high-quality food" and "water economy".

The creation of modern, integrated laboratories will enable conducting comprehensive research and intensification of knowledge transfer to enterprises in the following sectors: biotechnology, food industry (animal production and health food) and fodder, as well as veterinary services, which will be a direct contribution of science to the economy of the region and the country. The investment will be implemented on the area obtained from the Olsztyn Commune, at Trylińskiego street, in the immediate vicinity of the Olsztyn Science and Technology Park. The Center will include: the non-economic part (the main laboratory and administration building securing the Institute's needs) and the economic part (service laboratories, including the animal farm).

Project title: Improving the company's competitiveness by extending the offer with regional products

Beneficiary: „AN – TER” – General Partnership - FIJARCZYK AND PARTNERSHIP

EU funding: 310,422.50 zlotys



The aim of the project is to increase the innovation of the company through the use of process innovation, which will allow to obtain traditional bakery products with an increased hygiene standard and repeatable quality, referring to the economic heritage of the Warmińsko-Mazurskie region before 1989. The investment positively influenced further

improvement and modernization of bakery processes and enabled improvement in competitive position of the company. Project has a positive impact on the development of smart specialization "High-quality food." Currently, consumers have a need for bread produced using extended fermentation, because it is not only much more healthy and fit in the daily diet, but also has a better taste and aroma in comparison to bread produced using fast technologies.

The project envisages conducting educational activities related to the dissemination of knowledge in the society about the reconstructed economic heritage of the Warmińsko-Mazurskie Voivodeship. There are active promotional activities related to the launch of regional bakery products on the



market. They are carried out in places where products are sold. Thanks to this, consumers can associate the brand of a local producer with the quality and traditional taste of regional bread.

Project title: Improving the quality and comprehensiveness of treatment through the consolidation of health services in the field of conservative and surgical treatment

Beneficiary: Saint John Paul II City Hospital in Elbląg

EU funding: 32 919 212.92 zlotys

The subject of the project is the expansion of the operating theater and the modernization of rooms in the following departments: pediatric surgery, general surgery with oncology subgroup, obstetrics and gynecology with neonatological, otolaryngological, pediatric, traumatic-orthopedic subunit with hand surgery, ophthalmology, general and neurological rehabilitation and cardiac rehabilitation.

The operating block will have 5 operating theaters (gynecological, pediatric, general and 2 orthopedic rooms), patient and staff preparation rooms, and a 7-bed recovery room. The usable floor area of the operating block will amount to 2 266.7 m², while the total area of the modernized branches is approximately 7 848.3 m². The project also includes the purchase of equipment for the operating block and central sterilization plant and the above branches.

Project title: Repair and maintenance works of the MOK building for purposes of socio-professional activation

Beneficiary: Reszel Commune

EU funding: 3 475 1422.75 zlotys

The aim of the project is to revitalize the area, which has the task of promoting social inclusion of inhabitants, combating poverty, thus contributing to the improvement of the quality of life of residents. An important element of the activation of these people will be the creation of infrastructure for the provision of services enabling their restoration to function in society. The subject of the project is the modernization of the Municipal Cultural Center (part of

the insulation of foundations, major renovation of all rooms and the roof of the two-story building). The created infrastructure will be a stimulator of the social and economic development of the Reszel commune with the assumption of using all possible functions that it can perform. The most important factor will be increasing the level of occupational activation of the inhabitants of the revitalization area through the participation of residents in training, workshops related to raising professional qualifications, and the consequences will be an increase in physical availability on the labor market.

As part of the project, three stages of construction works are planned: construction and adaptation of the building for disabled people (purchase of a stairclimber), including replacement of window and door joinery, power installations, plumbing and sanitary, gas installations, installation of heating devices, ventilation and air conditioning, investor's supervision, promotion.
