

**Annual report for 2019**  
**from the implementation of the Regional Operational Programme**  
**for Warmińsko-Mazurskie Voivodship**  
**2014-2020**

## SUMMARY

*Regional Operational Programme for Warmińsko-Mazurskie Voivodeship 2014-2020* (ROP WiM 2014-2020) is focused on support of Warmia and Mazury economy and training of human resources for it, labour market integration, improving access to the public services, overcoming energy exclusion of the region improving, the natural environment, increasing the cohesion of transport system, urban revitalization and decreasing poverty in the region.

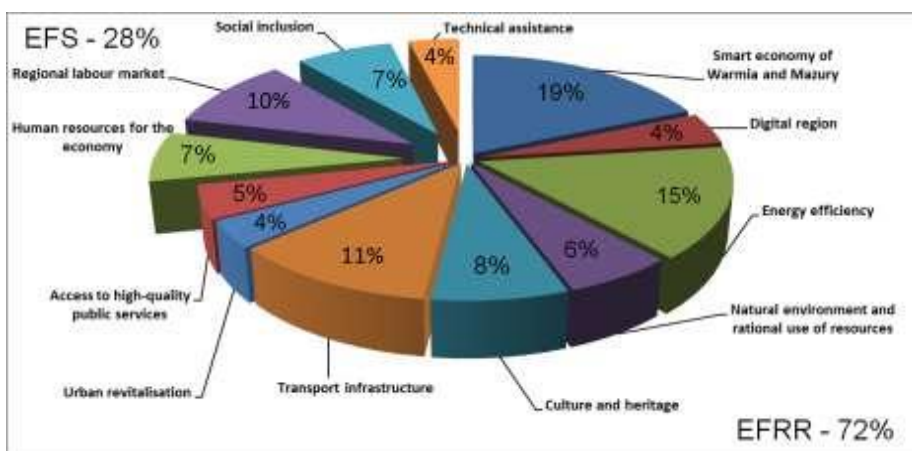
The expected results of the ROP W&M 2014 – 2020 will be achieved by means of thematic and territorial concentration of supported projects related to the following priority axes:

1. Smart economy of Warmia and Mazury.
2. Human resources for the economy.
3. Digital region.
4. Energy efficiency.
5. Natural environment and sustainable use of resources.
6. Culture and heritage.
7. Transport infrastructure.
8. Urban revitalisation.
9. Access to high-quality public services.
10. Regional labour market.
11. Social inclusion.
12. Technical Assistance.

The ROP WiM 2014 – 2020 is a two-fund operational programme, financed from the European Regional Development Fund (ERDF) and the European Social Fund (ESF).

The total allocation of EU funds equals 1,73 bn euro, of which 72% (i.e. over 1,24 bn euro) is financed by the ERDF and 28% (i.e. over 486 m euro) is provided by the ESF.

Estimated share of funds into certain priority axes of the Programme, was presented on the chart.



The ROP WiM 2014-2020 was adopted by the European Commission on 12 February 2015, subsequently on the 24<sup>th</sup> March, 2015 approved by the Management Board of Warmińsko-Mazurskie Voivodship. In addition to the Managing Authority of the ROP WiM 2014-2020 (the Management Board of the Warmińsko-Mazurskie Voivodship), three Intermediate Bodies participated in the implementation of the Programme: i.e. the Voivodship Labor Office in Olsztyn, Warmia and Mazury Regional Development Agency S.A. in Olsztyn and ITI Olsztyn.



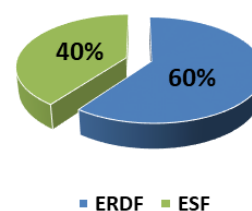
## Announced **478** calls, worth over **2.7 billion euro**.

Since the launch of the Programme conducted a total of 478 calls for proposals for funding.

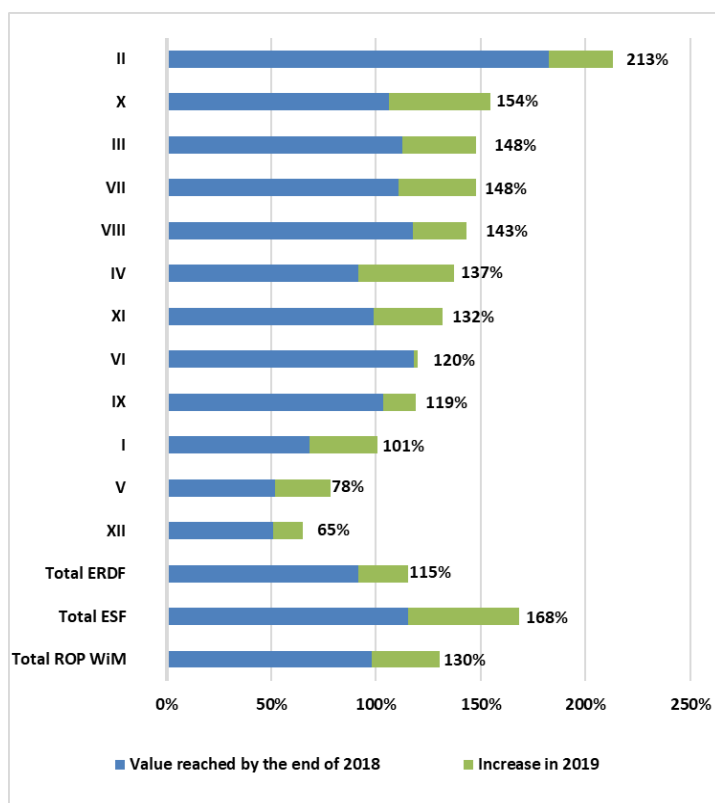
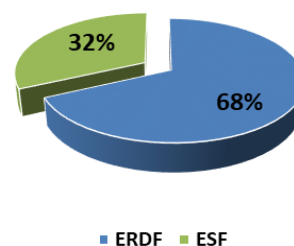
A larger number of them concerned actions financed from the ERDF (273 calls for proposals). As part of the ESF, 205 calls were made. The total amount of co-financing allocated to the beneficiaries amounted to 2.7 billion euro, of which 2.1 billion euro under the ERDF and 0.6 billion euro from the ESF.

As a result of the calls, the formal evaluation positively passed 6 574 submitted applications. Their total value amounted to nearly 3.2 billion euro, including 2.3 billion euro are the resources of the European Union. This represented approx. 130% of the allocation of the ROP WiM 2014-2020. In 2019, the value of applications correct in formal terms increased by over 556 million euro (about 32 p.p). The graph below presents the value of correct formal applications in relation to the allocation of priority axes.

Carried out calls for proposals - number of calls



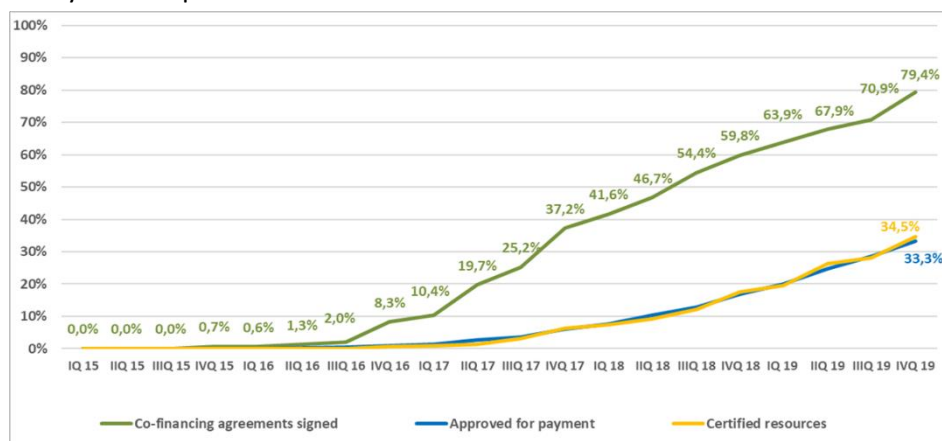
Carried out for proposals - value of calls

In 2019, the Managing Authority took steps to contract the funds of the ROP WiM 2014-2020 as much as possible. Their effectiveness is demonstrated by the implementation status of the Programme at the end of 2019. The value of co-financing agreements signed reached the level of 79,4% of the Programme allocation, of which as much as 20,2 p.p. was realized in 2019.



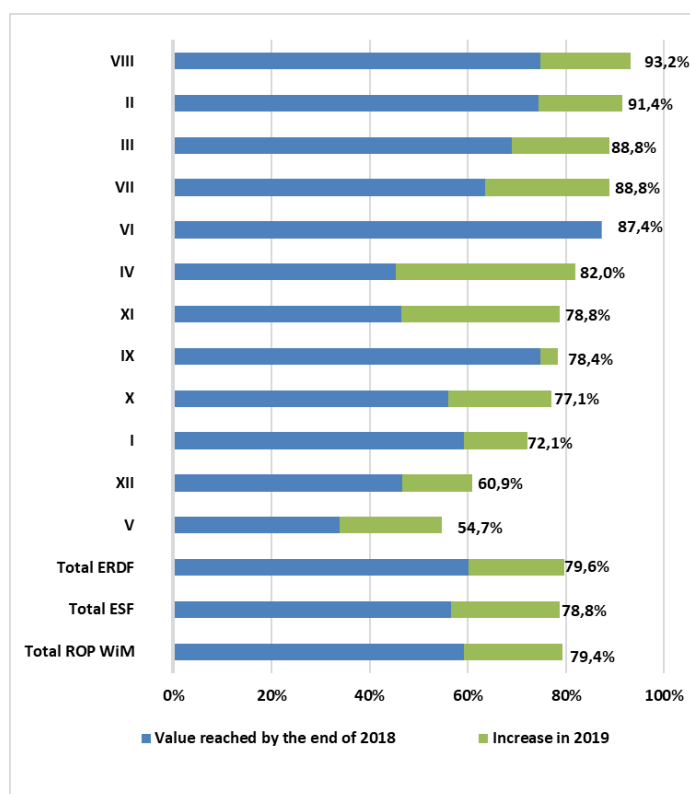
There was also a steady, regular increase of the expenditures (value of accepted payment applications) and their certification. Value of accepted applications on payment at the end of 2019 amounted into 33,3% of allocation of the Program, however value of certified funds amounted to 34,5% of the Program allocation.



**3 686 contracts were signed, for the amount of EU funding over 1,37 billion euro, which represents 79,4% of the Programme budget.**

By the end of 2019, 3 647 contracts were signed and 39 decisions were issued (for projects in the Technical Assistance axis) with a total value 2 billion euro. Nearly 1.37 billion euro is co-financing from the European Union (79,4% of the allocation of the ROP WiM 2014-2020), including 988 million

euro from the ERDF (about 79,6% of the ERDF allocation) and the ESF about 383 million euro (about 78,8% of the ESF allocation). The year 2019 brought an increase of 1 181 contracts/decisions for co-financing projects with EU funds in the amount of over 348 million euro. The value of co-financing agreements signed in relation to the allocation of individual priority axes is presented in the chart below.

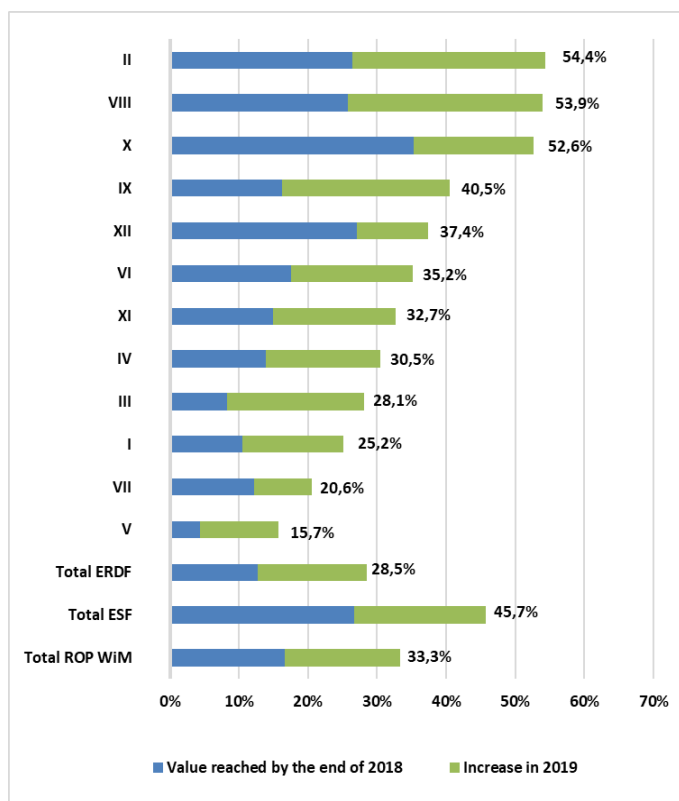

## Beneficiaries were paid nearly **576 million euro** of EU funds, which represents **33,3%** of the Programme budget.

The total value of European Union co-financing issued by beneficiaries, based on approved



applications for payment, amounted to nearly 576 million euro (around 33,3% of allocation of the ROP WiM 2014-2020), including ERDF for over 354 million euro (about 28,5% of ERDF allocation) and ESF amounting to over 222 million euro (about 45,7% of ESF allocation). The year 2019 brought an increase in the funds spent by the beneficiaries in the amount of over 288 million euro. The values of approved applications for payment in relation to the allocation of individual axes are presented in the chart below.

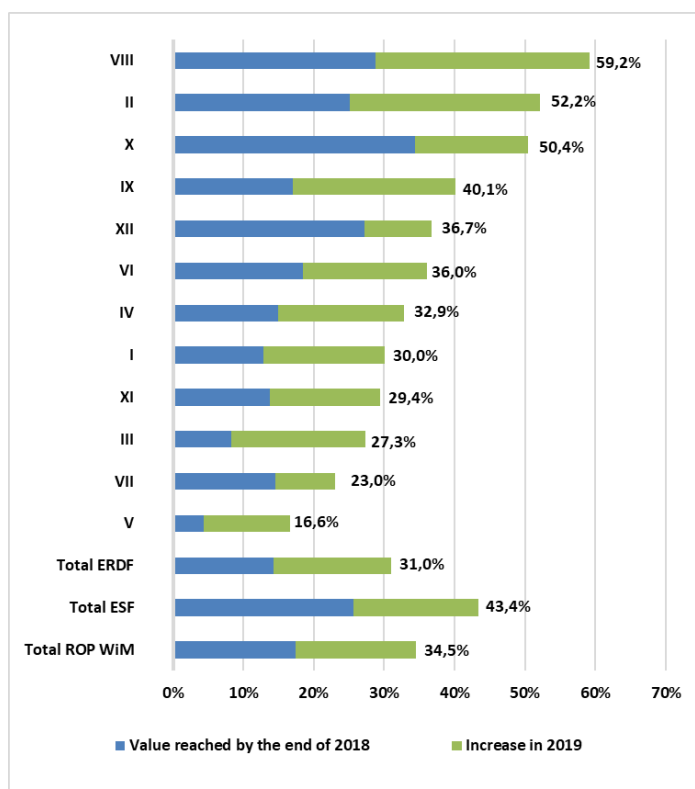

## The European Commission has approved over **596 million euro** of EU funds, which represents **34,5%** of the Programme budget.

The amount of over 702 million euro of eligible expenditure, incurred by the beneficiaries has been submitted for certification to the European Commission. Over 596 million euro of expenditures are



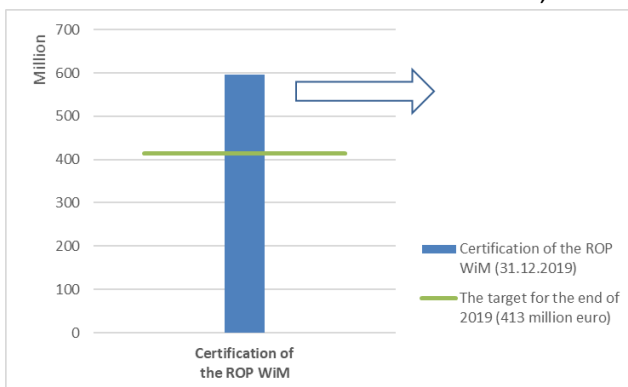
EU funds (about 34,5% of the allocation of the ROP WiM 2014-2020), including ERDF approx. 385 million euro (about 31,0% of ERDF allocation) and ESF for almost 211 million euro (about 43,4% of ESF allocation). The year 2019 brought an increase in EU funds certified to the European Commission in amount of nearly 294 million euro. The value of certifies EU funds in relation to the individual priority axes are presented in the chart below.

### RESOURCES CERTIFIED TO THE EUROPEAN COMMISSION (% axis allocation)

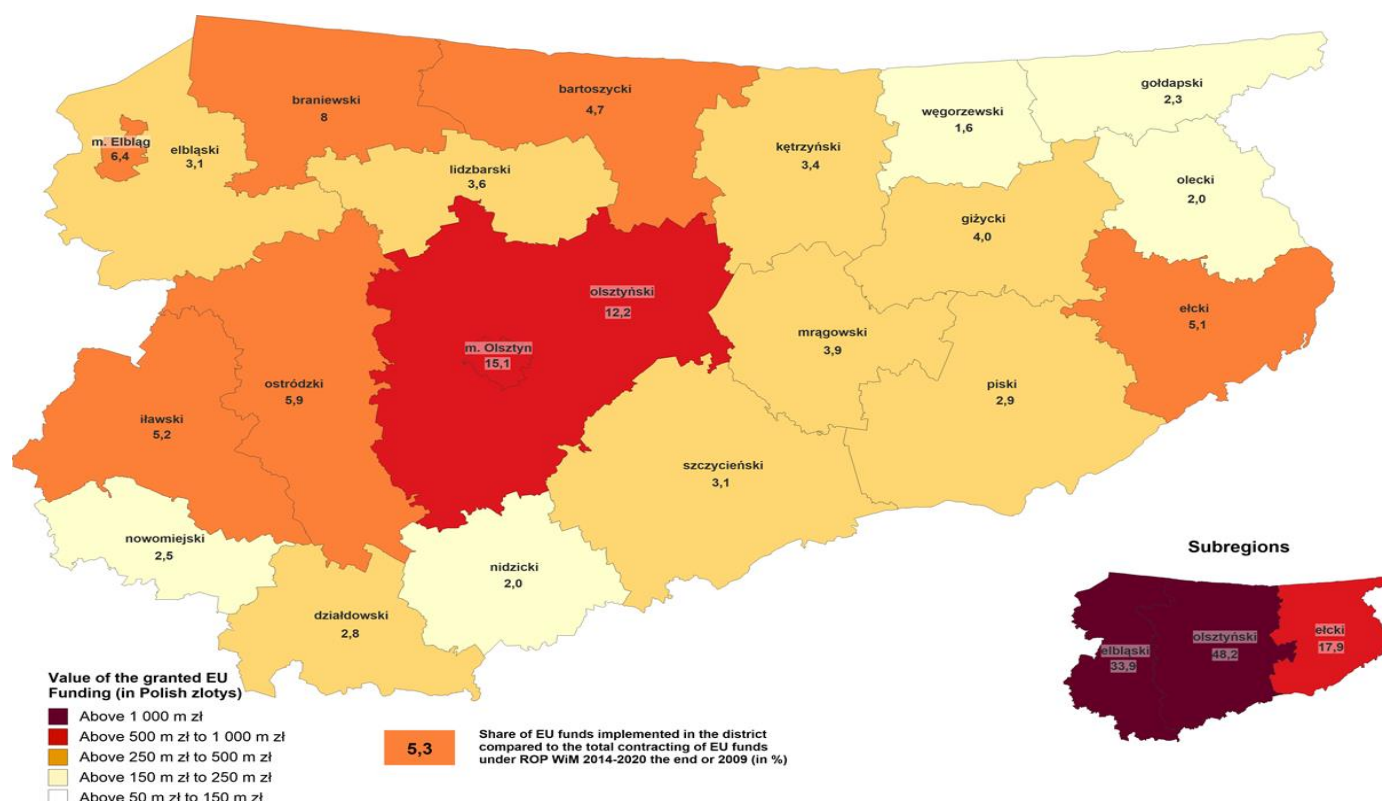

For each operational programme, the European Commission sets the levels of EU funds, that should be certified by the end of a given year (the so-called „n+3” rule. In the case of the ROP WiM 2014-2020, by the end of 2019, it was necessary to certify over 413 million euro of the EU contribution, and over 596 million euro was made, which is approx. 144% of the commitment resulting from the "n+3” rule.

Another target resulting from the 'n+3' rule falls at the end of 2020 years. For the ROP WiM 2014-2020, it amounts to over 597 million euro of the EU contribution. The level of certification achieved at the end of 2019. (i.e. 596 million euro) realizes this target in approx. 100%. The Managing Authority of the RPO WiM 2014-2020 does not identify a threat in achieving the assumed value.

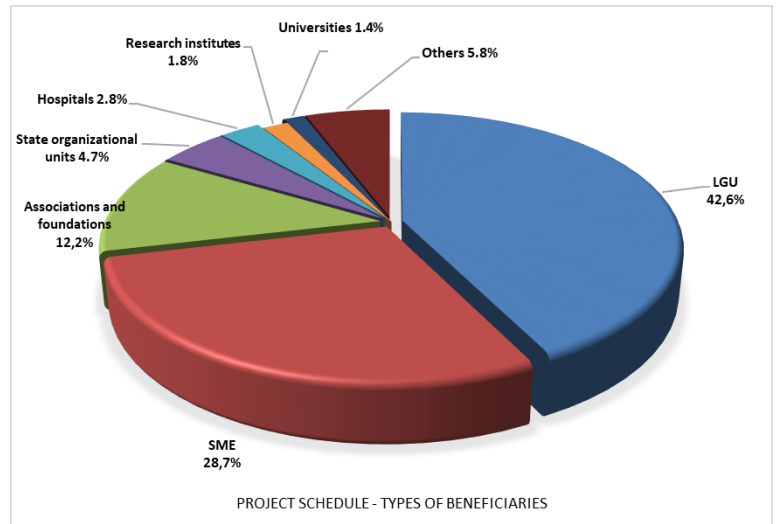


The spatial distribution of the support provided (excluding the projects of the Technical Assistance axis and implemented with the use of financial instruments) shows the uneven breakdown of subsidies (at the level of sub-regions as well as certain territorial self-government units). The highest value of EU funds went to the Olsztyn subregion (about 48% of the total contracting of EU funds). In the Elbląg subregion, the value of EU funds in the implemented projects was about 33.8% of the total contracting of EU funds, and in the Ełk subregion - about 17,9%. As the map below shows, the support went to each powiat. The most resources received poviats from the central part of the voivodship, i.e. the city of Olsztyn (over 15,1% of the total contracting of EU funds) and the olsztyński powiat (about 12,2%). A large percentage of the value of implemented projects also occurs in the braniewski powiat (8%). While comparing the breakdown of subsidy to axes specified in the Strategy of the Voivodeship, one may notice that the support is directed mainly to these areas, especially areas of low developmental potential, including near-border territories and the ones requiring restructuring and revitalisation.



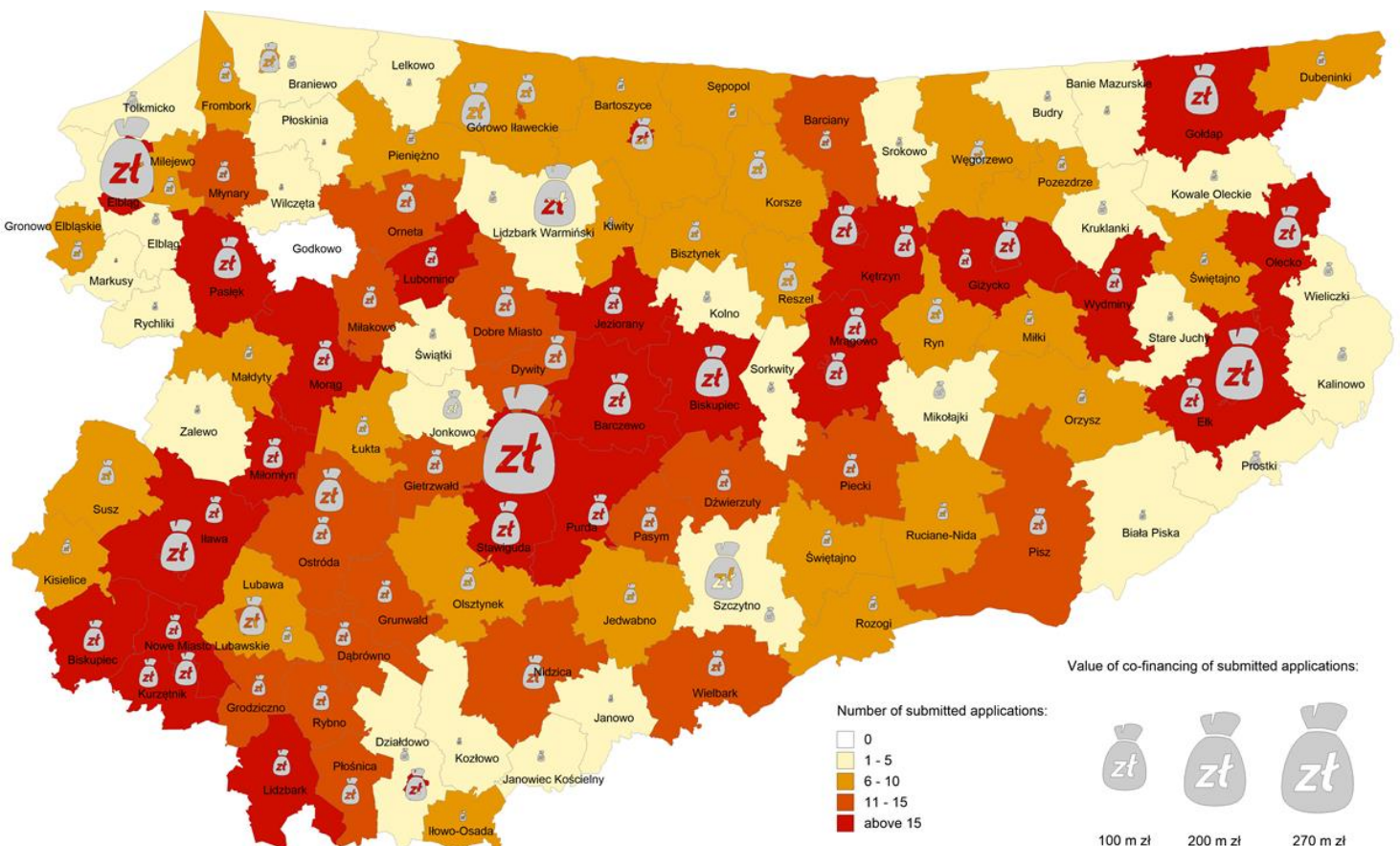


The main beneficiaries of the support were territorial self-government units and their organizational units, which received approx. 42,6% of the EU co-financing of all implemented projects. Besides, EU support went to enterprises – 28,7%, foundations and associations - 12,2%, state organizational units – 4,7%, hospitals – 2,8%. *research institutes* – 1,8% and *universities* – 1,4%. The share of other types of beneficiaries amounts into 5,8%.



The map below shows the interest in obtaining funds from the ROP WiM 2014-2020 among individual units of territorial self-government of the Warmińsko-Mazurskie Voivodeship. It is measured both, by the number of submitted applications for co-financing and their value.

As one can see, only one of the all local government units did not apply for funds under the ROP W 2014-2020. This is the Godkowo community. Compared to 2018 there was an improvement, because then identified three such communes. The most active in applying for funds under the ROP WiM 2014-2020 are the city of Olsztyn (75 applications submitted for funding) and other subregional cities, i.e. Ełk (41 applications) and Elbląg (31 applications).



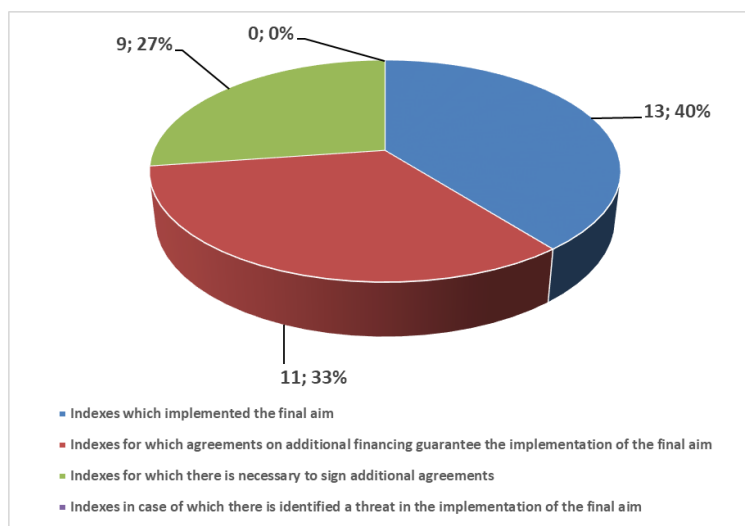
Local self-government units, which do not pursue any project within the ROP WiM 2014-2020 (have not signed any agreements for co-financing) is much more now, i.e. 5 communes of the Warmińsko-Mazurskie Voivodeship. Compared to 2018 there was an improvement, because then identified 14 such communes. The following map presents the distribution of projects implemented by individual communes from the Warmińsko-Mazurskie Voivodeship. The most occurs in the case of the city of Olsztyn (60 projects) and in other subregional cities, i.e. Elbląg (30 projects) and Ełk (30 projects).

The value of EU co-financing for projects implemented in rural areas was approx. 276 million euro. This represented more than 20,1% of all projects and approx. 16% of the allocation of the Programme.

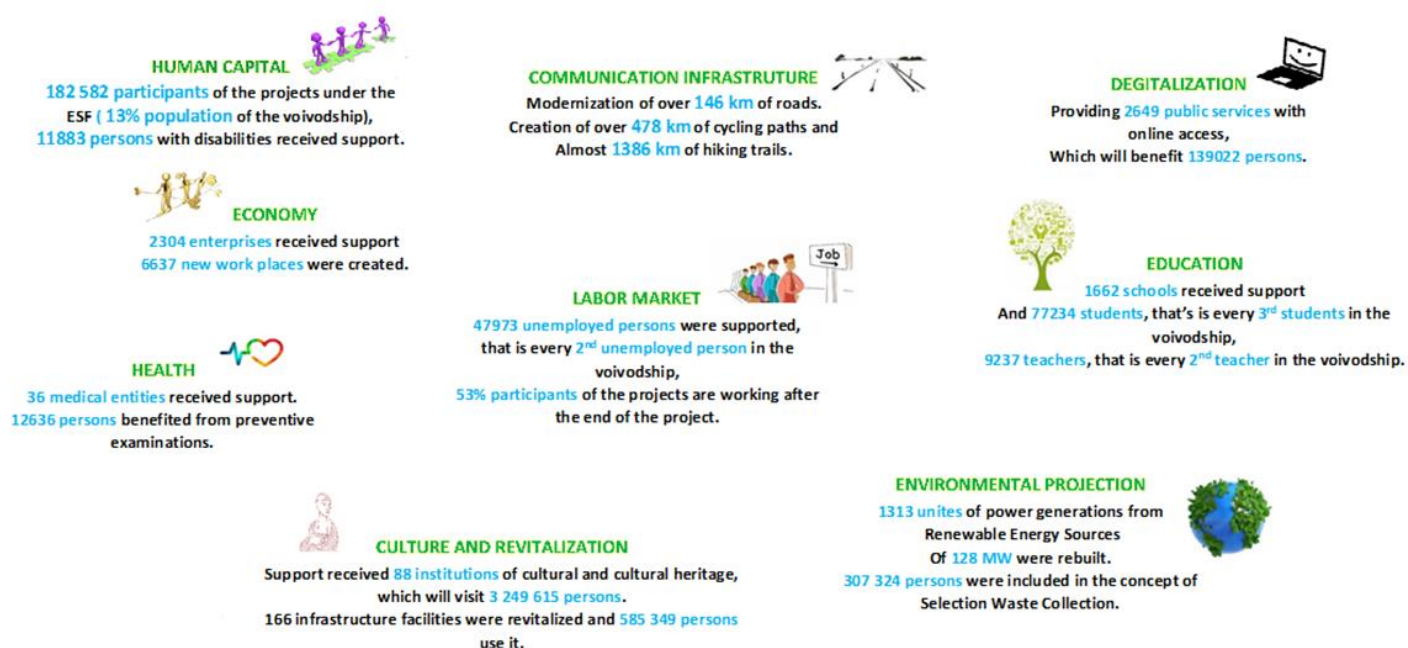
Approx. 6.5% of the ROP WiM 2014-2020 (113 million euro) was allocated for projects implemented from the Integrated Territorial Investment (in Olsztyn and its functional area) and the Integrated Territorial Investment" (in Elblag and Elk and their functional areas). By the end of 2019, the value of EU co-financing of signed contracts in the above-mentioned formulas amounted to over 97 million euro, of which about 55 million euro under ITI and above 42 million euro under ITI". This represents approx. 85% of the total allocation dedicated to the implementation of these instruments (almost 93,7% of ITI allocation and over 76,2% of ITI" allocation). The percentage of contracted allocation in instruments of Integrated Territorial Investments is much larger than the contracting level of ROP WiM 2014-2020 (i.e. 79,4%), which confirms the effectiveness of this support instrument.

ROP WiM 2014-2020 is also implemented using returnable financial instruments. An amount of over 60 million euro has been earmarked for them. Support in their use is granted to the SME's sector in the Warmińsko-Mazurskie Voivodeship. In May 29, 2017 an agreement between the self-government of Warmia and Mazury Voivodeship, and the Bank Gospodarstwa Krajowego was signed, conferring upon him the role of Manager of Fund of Funds. By the end of 2019, 534 agreements were signed with final recipients, for an amount of approx. 21,42 million euro. 509 enterprises received support under financial instruments.

Pursuant to the state at the end of December 2019, 13 indicators of performance framework (40% of all the indexes) have already reached the target value at the end of 2023. For subsequent 11 indexes of frameworks of performance (33% of all of them), the concluded agreements on additional financing guarantee the implementation of this purpose. For 9 indexes of framework of performance (27% of all of them) it is needed to sign additional agreements on additional financing in order to achieve the purpose assumed for 2023. Presently in the case of none of the indicators there is an identified threat for the implementation of target value.



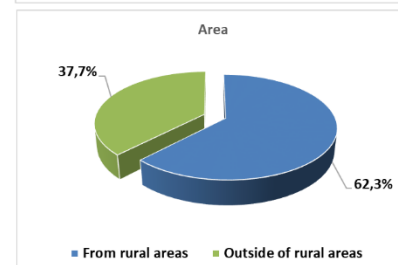
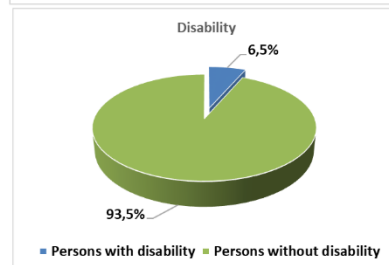
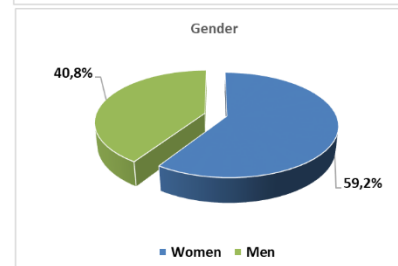
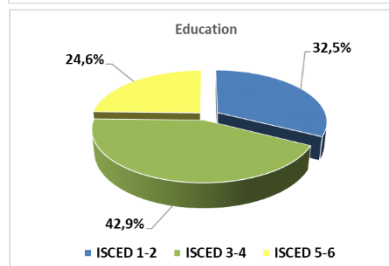
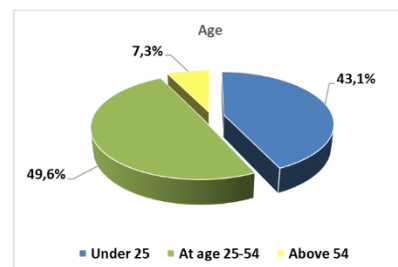
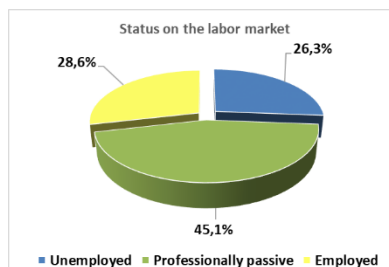
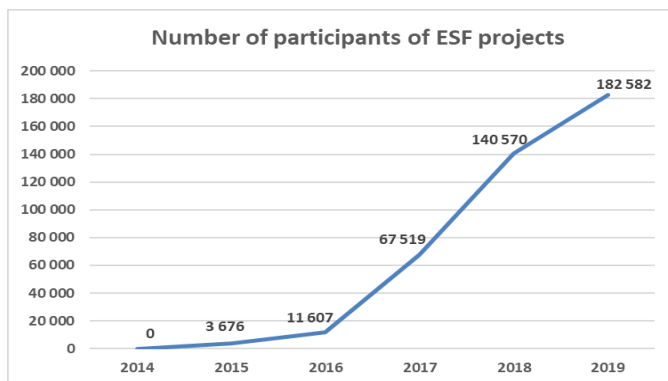
The year 2019 has already brought the first significant effects of the implementation of the Regional Operational Programme for the Warmińsko-Mazurskie Voivodeship for the years 2014- 2020. They are presented in the diagram below:



Data pursuant to currently signed agreements on additional financing and applications on payment since the start of the programme until December 31, 2019.

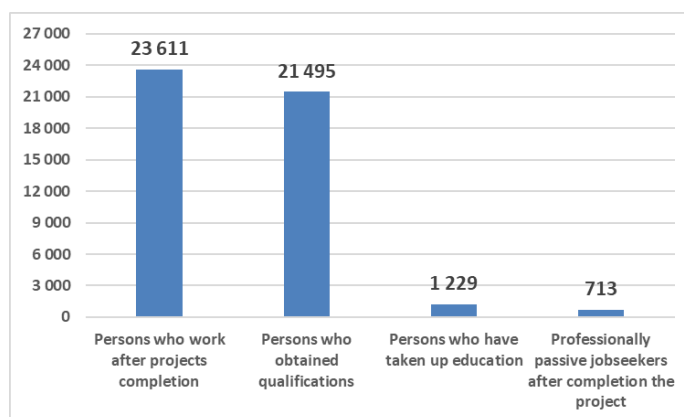


Nearly 183 thousand participants have been supported under the European Social Fund ROP WiM 2014-2020. This represents about 13% of the population of the Warmińsko-Mazurskie Voivodeship. The graphs below present both the growth of project participants in individual years of implementation as well as their characteristics in terms of age, gender, status on the labor market, education, areas and disability.



In 2019, the implementation of some projects has already been completed, as compared to the above, the first significant effects and results of the support provided as part of the European Social Fund ROP WiM 2014-2020 appear.

Of all participants supported under the European Social Fund, approx. 21,5 thousand people work after completing the project. A significant number, because more than 23,6 thousand persons, obtained qualifications as a result of the support received from the ROP WiM 2014-2020. The graph next, shows the results of projects implemented under the ESF, achieved at the end of 2019.



The way how EU support under the ROP WiM 2014-2020 can change and change the situation of the inhabitants of the Warmińsko-Mazurskie Voivodeship, their quality of life, work, education, is demonstrated by the statements of beneficiaries and participants under the following Webinars. As part of European Regional Development Fund and European Social Fund a number of investments implemented of completed by the end 2019 within ROP WiM 2014-2020, which constitute examples of „good practices” projects co-financed from EU funds. Below are a few of them.

**Project title:** B+R works over drawing up products dedicated to seniors

**Beneficiary:** TYMBARK - MWS Ltd.

**The amount of EU funding :** 6 236 997,92 zlotys

The project is implemented by Tymbark MWS Ltd. The necessity of project implementation is related to the development of the enterprise which by research and developmental activity gives rise to the development of the technology in the company in various scopes. The works shall be implemented in cooperation with a scientific entity which is to play a very significant role in the research process. The project aims at formation of products (product innovation of features limiting the degradation and absorption of anthocyanins in upper passages of digestive tract (stomach and small intestine) and at the same time allowing for reaching native forms of these substances to large intestine, where after releasing from the matrix of consumed product in the result of activeness of living there microflora and/or existing conditions they shall beneficially affect the functioning of that passage of digestive tract, and this way the whole body. It is of special meaning for the seniors at whom due to age there more often take place disorders of that passage of digestive tract while at the same time lowering the quality of living. The



process innovation stands for precise adaptation of conditions of manufacturing of half-products (concentrate, puree) from various raw materials, among others a violet carrot and blackcurrant, allowing for obtaining rich and stable sources of bioactive compounds.

**Project title:** The utilisation of renewable sources of Energy by installation of photovoltaic panels and heat pumps in The Order of the Sisters of Our Lady of Mount Carmel Monastery in Elbląg

**Beneficiary:** SISTERS OF OUR LADY OF MOUNT CARMEL MONASTERY IN ELBLĄG

**The amount of EU funding:** 502 845,07zlotys



The investment stands for purchase and assembly of photovoltaic power plant of power 22,55 kW and assembly of 2 air heat pumps of total heating power 100 kW (electrical power 29,8 kW) on plots no. 94, 95 and 99 section 0010 in Elbląg by The Order of the Sisters of Our Lady of Mount Carmel Monastery. Photovoltaic panels use the photovoltaic phenomenon to process the solar radiation into power. By means of cable connections they hand over the power

to inverters, where there takes place change of direct current into alternating current. The project also assumes the assembly of 2 air heat pumps of heating power 100 kW, for the purposes of central heating. The heat pump is a device that uses basic rules of physics – it forces the flow of heat from the area of lower temperature to the place where the temperature is higher.

**Project title:** Construction of ecological didactic path along the bank of Mildzie Lake in Miłakowo Commune in order to protect in-situ endangered species and natural habitats

**Beneficiary:** MIŁAKOWO COMMUNE

**The amount of EU funding:** PLN 860 456,28 zlotys

The aim of the project is the protection of habitats of eutrophic lake and preservation as well as enrichment of the living by the bank of the lake species of plants and animals, together with making available the area to the wider group of users due to the construction of ecological path along the lake bank (with a small architecture and accompanying infrastructure).



The planned works relate to the performance of planting plants, in total 8 195 pieces, sowing of flowery meadow, construction of a hotel for insects and nesting boxes for birds, placing the educational boards, performance of mineral path and management of the beach area, performing the access road with two parking and small infrastructure, i.e. a bench, floating platforms, wooden arbours, loungers, dust bins as well as changing rooms.

**Project title: "LOGS OF CULTURE" – new space and new opportunities for  
the artistic development in Orzysz**

**Beneficiary:** CULTURE CENTER IN ORZYSZE

**The amount of EU funding:** 712 283,30 zlotys



Culture center in Orzysz has a vast green area and five buildings of total area almost 2 thousand m<sup>2</sup>. Values create a high potential for extending the artistic offer and organisation of external events directed for residents and tourists. The scope of works covers: -renovation works covering buildings 9a, 9b, 9c 9e (among others renovation of roofs, exchange of window carpentry, external facades, renovation works on walls and external ceilings), adaptation of glades of culture for artistic

actions – equipment of the object in necessary devices, musical instruments and equipment, IT equipment, ICT, construction of website and drawing up feasibility study of the project. The project shall be focused on the region-creative actions improving and building the ties of commune residents and voivodeship, adapting the offer to modern cultural activity.

**Project title: Revitalisation of social space of the Old Town in Górowo Iławeckie  
HARBOR FOR FAMILY**

**Beneficiary:** GÓROWO IŁAWECKIE CITY COMMUNE

**The amount of EU funding:** 2 116 286,76 zlotys

Project stands for development of the public space in the city centre, by formation of the area of social mobilisation. The covered scope: development of public space on the Plac Ratuszowy as places of meetings of residents by execution of new (while keeping historical style) development of small architecture (benches, cages, lanterns, etc.) together with monitoring. One predicts the formation of conditions for organising summer café,



especially for the needs of activity of Social Integration Club, execution of facade of centrally located a historic building of the town hall and development of the old town from the side of the town hall, granting new functionality to historic (degraded and excluded from public space) basements of the town hall by formation of Social Integration Club together with equipment (totally entered into records of fixed assets) covering a club with kitchen back premise and toilet, multimedia-training room with access to internet, making available of the space of the ground floor of historic building of the town hall together with the possibility of using the free-of-charge stationary internet and local system of multimedia information directed to individuals with impaired sight (reader), deaf people (sign language).



"Harbor for family" Project is directed to the residents of the City: Górowo Iławeckie living on the area covered by revitalisation. It was used by 18 families which constitutes 80 people. The project assumes



a row of actions which are significant for families facing the care-educational problems. On the territory of city there does not function any centre where families could use the support of the specialists. The main aim of the project is first of all family counselling. The project participants will be able to use the advice and workshops conducted by a psychologist, family assistant and therapists. Another aim is family animation which actions aim at development of the ambitions, repair of family ties and maintaining them among family members by common participation in thematic workshops, developmental two-surface classes organised for children as well as for their families, family animation in external environment. Within the project the families affected by violence and

facing the addictions of a parent from alcohol, drugs and other stimulants will be able to use the support of the specialists and participate in the therapy. There shall be formed „premise emergency” – an apartment for sudden interventions for individuals affected by family violence.

### Project title: On the way to activeness

**Beneficiary:** FEDERATION OF SOCIAL ORGANISATIONS OF WARMIŃSKO-MAZURSKIE VOIVODESHIP

**The amount of EU funding:** 6 302 885,37 zlotys



Increase of the degree of social, health, educational and professional activeness of 263 women and 180 men living on the territory of the city of Olsztyn and communes: Stawiguda, Purda, Gietrzwałd, Jonkowo, Barczewo. There shall be taken up actions aiming at social and health activeness (workshops of social and life competencies, support of psychologists, support groups, specialised counselling, social work, local animation) and educational as well as professional (professional counselling,

professional and qualification courses, internships, labour intermediation). The innovation in the project shall be the application of the JOBfirma model, simulation enterprise shaping the autonomy and habits necessary in taking up the employment. In the effect of the project 170 women and 110 men shall increase their social activeness and 65 women and 35 men shall obtain employment.

**Project title: Synergy**

**Beneficiary:** ARCHE PROJECT

**The amount of EU funding:** 849 787,50 zlotys

The main aim of the project is increasing the access to the social services and integration with the local environment of 102 people (65 women and 37men)/26 families, residents of Wydmyny community endangered by poverty and/or social exclusion by covering them by their complete support. The project anticipates the implementation of the following actions: the activity of local animators, psychological workshops, workshops from assertiveness, workshops from management of house budget, workshops on family volunteering, workshops related to social economics, workshops related to strengthening the family ties, common family trips.

PROJEKT ARCHE

**Project title: Included and independent**

**Beneficiary:** INTEGRATIVE SPORTS CLUB "ATAK"

**The amount of EU funding:** 164 347,50 zlotys

The project was prepared by INTEGRATIVE SPORTS CLUB ATAK from Elbląg operating for 20 years actively within social activeness of the disabled. The aim of the project is activating and social integration of 20 individuals aged 15-64 years old threatened by poverty and/or social exclusion from Elbląg and Elbląg region. The project assumes using the services supporting proper functioning of the family and giving rise to increase of the quality of everyday life, services supporting integration of families with the local environment (among others organisation of Poland's championships in beach volleyball), specialised counselling (psychologist, professional counsellor), financing the stay in training apartments for the period of the process of becoming autonomous. In order to come back to the social life, there were planned actions aiming at shaping life skills, functioning independently and self-service. There was planned housing training for the participants. The participants shall be able to develop skills of deciding, solving problems, believing in yourself, taking the responsibility, working in a group as well as fulfilling various social roles.

**Project title:** We are not going slower – social services and integration

**Beneficiary:** POLISH ASSOCIATION FOR THE BENEFIT OF PERSONS WITH INTELLECTUAL DISABILITY CIRCLE IN ELBLĄG

**The amount of EU funding:** 1 443 544,80 zlotys

Polish Association for the benefit of persons with Intellectual Disability Circle in Elbląg and Partner of the project Foundation of the development of social-economic innovations "Innovation" noticed that the main social problem is too small offer of social services directed directly to the persons threatened by poverty or social exclusion and their families as well as too low number of offers of direct support directed directly to individuals of a significant or moderate degree of disability, with multiple disabilities and intellectual disability. While replying to the needs identified on the territory of Elbląg there was project the aim of which is facilitation for the individuals threatened by poverty or social exclusion an access to high quality services by direct support of a project participant and its family. Within the task we shall support 170 disabled individuals and their family from city of Elbląg who are threatened by poverty and/or social exclusion and who experienced multiple exclusion, also including unemployed individuals in the third profile The idea of the project is formation of access to intellectual disabled individuals to social services of high standard among others to learning, to living in a society without fixed institutional care and aid from side of parents/guardians. The implementation of the integrated mobilisation-integrative services within the project shall stand for organisation of actions supporting the participant himself and his surroundings. These services are among others: training housing, intervention emergency and care services, volunteering actions, specialised counselling: legal and psychological, training and workshops within School for parents which certainly shall improve the condition of the beneficiaries and their families and shall facilitate their access to social services, including integration with the local environment.
